## KESTREL CAMP SITES

Each site is \$ 72 for the camp out (both nights) except #170 (double site) is \$ 144  
Vehicle Entrance Fee: Everyone must pay \$5/vehicle/day unless they have an Idaho  
Passport or annual Parks Pass

Reservations will close when sites are filled.

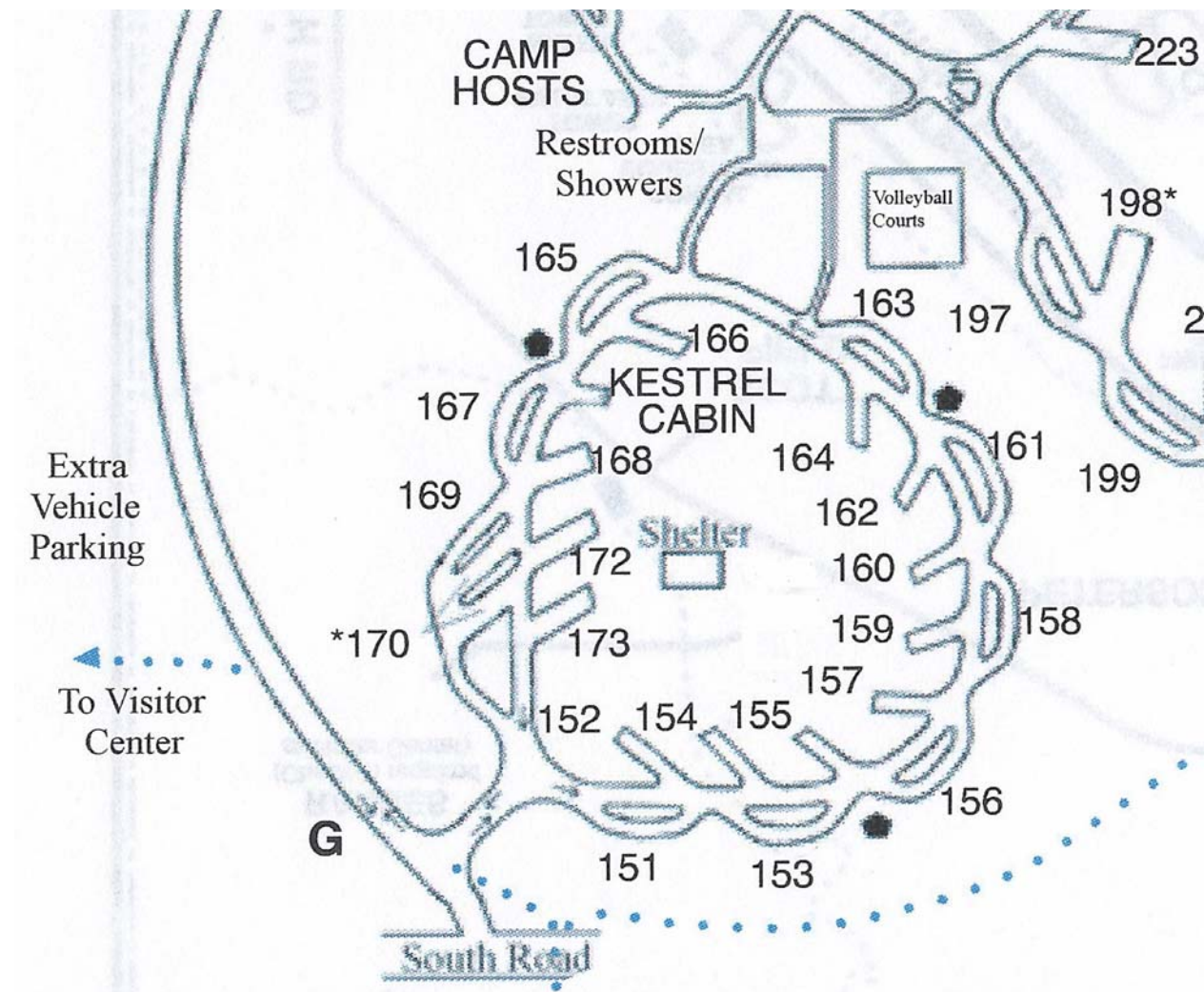
Each site has water and electricity. You may NOT put a tent in the RV site.

All sites allow for a maximum of ONE RV and ONE 10'x12' tent (or 2 pup tents)  
which must fit entirely on the "pad" - Maximum # of persons on site: 8

Site # 170 allows TWO RVs and ONE 10'x12' tent (or 2 pup tents) which must fit  
entirely on the "pad" Maximum # of persons on site: 12.

Baths/showers are located in the center of the Waldron group (so they are close.)
